

ARTICLES OF INCORPORATION of TCR SERVICES INCORPORATED

(a Florida corporation)



The undersigned, acting as incorporator of **TCR Services Incorporated,** proceeds to form a corporation under the Florida General Corporation Act, and adopts the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME
