**ARTICLES OF INCORPORATION  
OF  
PETER SAVARESE, P.A.**

THE UNDERSIGNED, incorporator, a natural person competent to contract and duly licensed to render services as an attorney and counselor of law, hereby organizes and incorporates under the Florida Professional Service Corporation Act, Florida Statute 621, and Florida Statute 607, not in conflict therewith.

**Article I – Name and Address**

The name of this corporation is Peter Savarese, P.A. and the principal place of business and mailing address is 15646 84<sup>th</sup> Avenue North, Palm Beach Gardens, Florida, 33418.

**Article II – Commencement and Duration**

This corporation shall commence on the date of filing of these Articles and the duration of this corporation is perpetual. The effective date of this corporation shall be five business days prior to the date of receipt by the Florida Department of State, Division of Corporations.

**Article III - Capital Stock**

This corporation is authorized to issue 1,000 shares of common stock, par value \$0.01 per share.


**Article VII – Bylaws**


