OF

ALVIN BURKETT, INC.

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act do hereby adopt the following Articles of Incorporation:

ARTICLE ONE

NAME OF CORPORATION

The name of the corporation is ALVIN BURKETT, INC.

ARTICLE TWO

PRINCIPAL OFFICE
