**ARTICLES OF INCORPORATION  
OF  
WIRESPEC CORPORATION**

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the provisions of Chapter 607, Florida Statutes:

**ARTICLE I. NAME**

The name of this corporation is Wirespec Corporation (the "Corporation").

**ARTICLE II. - ADDRESS**

The principal business address and mailing address of the Corporation is:

**ARTICLE III. - CAPITAL STOCK**

The Corporation is authorized to issue One Hundred (100) Million shares of Common Stock, having a par value of \$0.001 per share, and Ten (10) Million shares of Preferred Stock, having a par value of \$0.01 per share.

The Preferred Stock may be issued from time to time in series, with such designations, preferences, conversion rights, cumulative, relative, participating, optional or other rights, qualifications, limitations or restrictions thereof as shall be stated and expressed in the resolution or resolutions providing for the issuance of such Preferred Stock, adopted by the Board of Directors pursuant to the authority granted in these Articles.

**ARTICLE IV. - INITIAL REGISTERED

The initial registered office of this Corporation shall be at 2601 S. Bayshore Drive, Suite 1600, Miami, Florida 33133, and the initial registered agent of this Corporation at such office shall be A Z Registered Agent Corporation.
