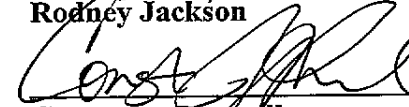

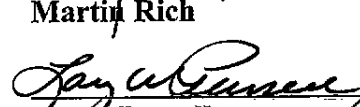
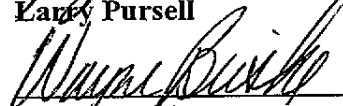
Initial shareholders/officers will have equal ownership and voting rights in the corporation as follows:
