Dear Sir/Madam:

I am writing on behalf of and at the request of my client, Great Play International, Inc. and its President, Clay Ladouceur.

When I received Mr. Ladouceur's records to begin preparation of Mr. Ladouceur's corporate return this year (for Tax Year 2001) after filing an extension, I found the enclosed reinstatement application which Mr. Ladouceur thought was for me to prepare his tax return. He had not opened it. I checked the online records and found that, indeed, Mr. Ladouceur's corporation had been administratively dissolved for failure to file his 2001 UBR.

I realize it is the responsibility of the corporate officer to understand what forms need to be filed and when, but this (2001) being his first year to receive a UBR, he just didn't know what he had to do, and made an innocent error. I know the Florida legislature and/or Department of State passed some legislation last summer regarding a more lenient reinstatement policy for new corporations and/or first failures to file. It is based on this that I respectfully ask that you except this as reasonable cause and accept the enclosed check for \$ 361.25 (for 2001 and 2002 UBR plus \$ 61.25 Annual Report Fee) and ask that the additional reinstatement fee be waived. I have accepted status as Registered Agent to insure that this problem does not occur again.

We hope this letter explains our request, and we appreciate your consideration in this matter.
