THE UNDERSIGNED, FOR PURPOSES OF FORMING A CORPORATION UNDER THE FLORIDA GENERAL CORPORATION ACT, HEREBY ADOPT(S) THE FOLLOWING ARTICLES OF INCORPORATION:

**ARTICLE I - NAME AND PRINCIPAL ADDRESS**

The name of this Corporation is Custom Boat Repair, Inc., and its principal address is 1110 Green Pine Blvd. C-3, West Palm Beach, FL 33409.

**ARTICLE II - DURATION**

This Corporation shall have perpetual existence commencing on the date of the filing of these Articles with Department of State.

**ARTICLE III - PURPOSE**

This Corporation is organized for the purpose of transacting any or all lawful business.

**ARTICLE IV - CAPITAL STOCK**

The aggregate number of shares which the Corporation shall have to issue is 1,000, all of

which shall be common shares with par value of \$1.00.





The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.


