**ARTICLES OF INCORPORATION
OF

The undersigned, Professional Corporation in accordance with Chapter 621 of the Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is **FORRY POOL SERVICE, INC.**

ARTICLE II. PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

The Board of Directors is empowered to make, alter or repeal the Bylaws of the corporation without restriction of their powers conferred by statute.

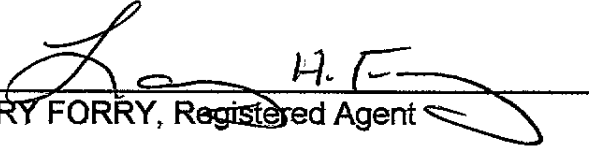

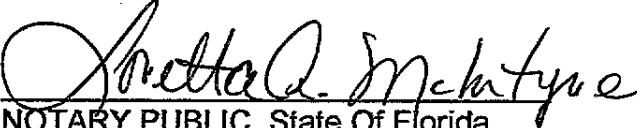
