ARTICLES OF INCORPORATION OF GLOBAL HR SOLUTIONS, INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

Article I Name

Section 1.1. Name. The name of this corporation shall be Global HR Solutions, Inc

Article II Principal Office and Mailing Address
