# ARTICLES OF INCORPORATION

## ARTICLE I

### NAME

The nature of the business to be transacted by the corporation is:

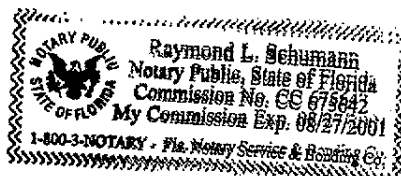
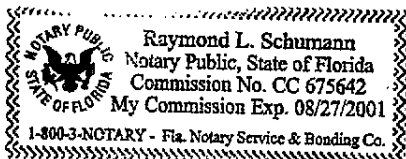
