ARTICLE 1. - NAME

The name of the corporation is QUARTER K, INC.

ARTICLE 2. - PRINCIPAL OFFICE

The principal office of the corporation shall initially be at 6329 Old Court Street, North Port, FL, 34286. The corporation may change its principal office from time to time as permitted by law.

ARTICLE 3. - MAILING ADDRESS

ARTICLE 4. - PURPOSE

This corporation is organized for the purpose of transacting any and all lawful business.
