Articles of Incorporation

of

In compliance with the requirements of Florida Statutes, Chapter 607, the undersigned, being a natural person, does hereby act as the incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is: Non Stop USA, Inc.

ARTICLE II

The street address of the principal office of the Corporation is: 1880 Mathis Road, St. Cloud, Florida 34771

ARTICLE III

The purpose for which the Corporation has been formed is to provide tour guide services to the public.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is one thousand (1,000) having a \$ 1.00 par value, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. The consideration to be paid for each share shall be fixed by the Board of Directors. Common Stock of the Corporation shall be issued as "small business corporation" stock in accordance with the plan or plans under the provisions of Section 1244 of the Internal Revenue Code of 1986.

ARTICLE V

The initial Board of Directors shall consist of two (2) member. The name and address of the persons who will serve on the initial Board of Directors are:


ARTICLE VIII

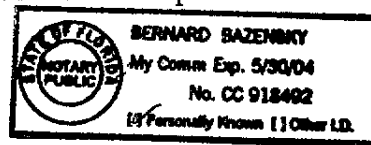
