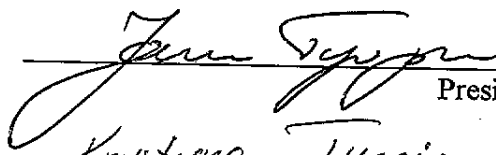

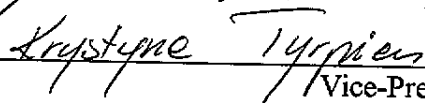
ARTICLE VIII - Powers
