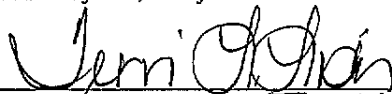

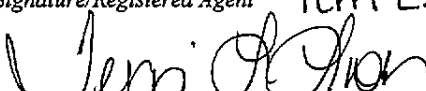
ARTICLE VIII AMENDMENT
