

ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporations Act, adopt the following articles of incorporation for such corporation.

1. The name of the corporation is Rack Masters Hunting Club, Inc.
2. The address of the corporation is 430 Woodcrest Drive, Ft. Pierce, Florida 34945.
3. The period of its duration is perpetual.
4. The purpose is to engage in activities relating to the hunting of animals and birds inhabiting parcels of land leased from others or owned by the incorporators. Also included shall be the use of properties, leased or otherwise, for the purpose of camping, fishing and any activity related to the enjoyment of the facilities by members of the club and their guests and any other business permitted under the laws of the United States and Florida.
5. The corporation shall have authority to issue one thousand (1,000) shares of stock, all of one class, One Dollar (\$1.00) per share par value.
6. The address of its initial registered office is 430 Woodcrest Drive, Ft. Pierce, Florida 34945 and the name of its initial registered agent at said address is Pat Prescott.




