**FIRST:** The name of the Corporation is G. AND C. FASHIONS, INCORPORATED

**SECOND:** Its principal office in the State of Florida is: **6057 North West 80th. Avenue**, in the City of **Tamarac** County of **Broward**. FLA. 33321

**THIRD:** The nature of the business and objects and purposes proposed to be contracted, promoted and carried on, are to do any and all things herein mentioned, as fully and to the same extent as any natural persons could and might do, in any part of the world, viz:


