**DIRECTORS**

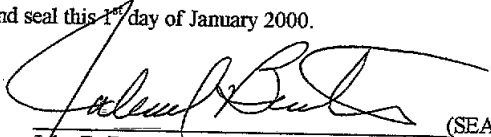

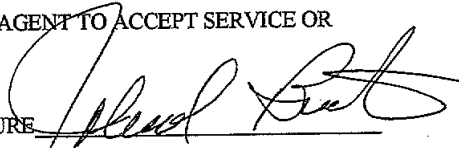

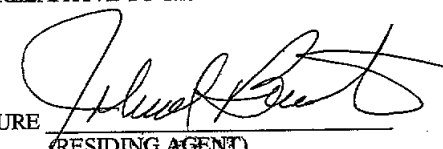
