ARTICLES OF INCORPORATION OF

HELEN M. SMITH, INCORPORATED

I, the undersigned natural person, competent to contract, acting as incorporator of the corporation described herein (the "Corporation") under the General Corporation Law of the State of Florida make, subscribe, acknowledge and file the following Articles of Incorporation for the Corporation.

ARTICLE I

<u>NAME</u>

The name of the Corporation is: Helen M. Smith, Incorporated.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted is: To engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE III

CAPITAL STOCK

The amount of authorized capital stock is One Thousand and 00/100 Dollars (\$1000.00), consisting of one thousand (1000) shares of common stock.

ARTICLE IV

PRE-EMPTIVE RIGHTS

INDEMNIFICATION


