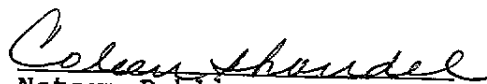
ARTICLE X AMENDMENT

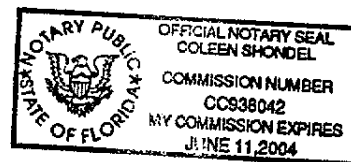
