ARTICLES OF INCORPORATION

OF

Article I

Name and Address

The name of this corporation is Weston Road Title, Inc. whose place of business is located at 10138 U.S. 19 Port Richey FL 34668

Article II

Duration

The term of existence of this corporation shall be perpetual.

Amendment


