ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

- 1. The name of the corporation is The Sheetie Corporation
- The address of the corporation is 3838 Tamiami Trail North, Suite 416, Naples, Florida 34103.
- 3. The period of its duration is perpetual.
- 4. The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.
- 5. The corporation shall have authority to issue five thousand shares, all of one class, one dollar par value.
- 6. The address of its initial registered office is 3838 Tamiami Trail North, Suite 416, Naples, Florida 34103, and the name of its initial registered agent at said address is Christian B. Felden.
- 7. The initial Board of Directors shall consist of five (5) members, who need not be residents of the State of Florida or shareholders of the corporation.

its property and assets with the vote or written consent of the holders of 75% of the shares of the corporation entitled to vote, and not otherwise.

12. The holders of the common stock of this corporation shall have full preemptive rights to purchase, at prices, terms and conditions as shall be fixed by the Board of Directors, such of the shares of the stock of this corporation as may be issued for money, or any property or services from time to time, in addition to that stock authorized and issued by the corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.
