of any firm of which any director or officer is a member, or any company of which any director or officer is a shareholder, director or trustee, or any trust of which any director or officer of the corporation is a trustee or beneficiary, is in any way interested in such transaction or gains or profits directly or indirectly realized by him by reason of the fact that he or any firm of which he is a member, company of which he is a shareholder, director or trustee, or any trust of which he is a trustee or beneficiary, is interested in such transaction or contract or act. Without limiting or qualifying the foregoing, if in any judicial or other inquiry, suit, cause or proceeding, the question of whether a director or officer of the corporation has acted in good faith is material, then notwithstanding any statute or rule of law or equity to the contrary, his good faith shall be presumed, in the absence of proof to the contrary by clear and convincing evidence.

TENTH:

Except as otherwise provided herein, every person who is or was a director or officer of the corporation and his heirs and legal representatives are hereby indemnified by the corporation against expenses and liabilities actually and reasonably incurred by him in connection with the defense of either (1) any action, suit or proceeding, threatened, pending, or completed ("Proceeding"), to which he may be a party defendant, (2) any Proceeding by or in the right of the corporation to procure a judgment in its favor by reason of the fact that he is or was a director or officer of the corporation or (3) any claim of liability asserted against him, by reason of his being or having been a director or officer of the corporation, if he acted in good faith and in a manner he reasonably believed to be in, or not opposed to, the best interests of the corporation ("Good Faith") and, with respect to any criminal action or Proceeding, he had no reasonable cause to believe his conduct was unlawful ("Reasonable Cause"). The termination of any Proceeding by judgment, order, settlement, conviction or upon a plea of nolo contendere or its equivalent shall not, of itself, create a presumption that he did not act in Good Faith and with Reasonable Cause. The corporation shall not, however, indemnify any director or officer with respect to any matter in any Proceeding by or in the right of the corporation to procure a judgment in its favor in which he shall be finally adjudicated liable for negligence or misconduct in the performance of his duties as such director or officer, nor in the case of a settlement thereof, unless the court having jurisdiction of the proceeding against such director or officer shall determine upon application that such officer or director, in view of all the circumstances of the Proceeding, is fairly and reasonably entitled to indemnity, despite the adjudication of liability, and those directors of the corporation not parties to the Proceeding constituting a quorum shall determine, upon the finding and recommendation of corporation), by a majority vote that such officer or director is fairly and reasonably entitled to indemnity. The foregoing right of indemnification shall be in addition to all rights to which any such
