ARTICLE I - NAME and PRINCIPAL PLACE OF BUSINESS

The name of the corporation is Alliance Textiles, Inc., and principal place of business shall be located at 455 Douglas Avenue, Suite 2155-26, Altamonte Springs, Florida 34714.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles of Incorporation with the Department of State.


ARTICLE X - AMENDMENT
