**I.  
Name**

The name of the Corporation is **J.A. Roman Landscape & Tree Service, Inc.**, hereinafter referred to as the "Corporation."

**II.  
Purposes**

The purpose of the Corporation is to transact any and all lawful business for which corporations may be incorporated under the laws of the State of Florida, as they may be amended from time to time.

**III.  
Principal Office and Registered Agent**

The principal office of the Corporation is **15533 SW 102 Ct., Miami, FL 33157**. The Corporation may maintain offices and/or transact business at other locations, either within or without the State of Florida. Duration**

The duration of the Corporation shall be perpetual.

Initial Business**

The initial business of the Corporation shall be: **Landscape and Tree Service**

The total number of shares the Corporation shall have authority to issue is **100**, each share to have a par value of **\$1.00**.
