# ARTICLES OF INCORPORATION OF SUBVERSION RECORDS, INC.

# Article I

Name. The name of this Corporation is Subversion Records, Inc.

# Article II

Principal Office. The principal place of business and mailing address of this corporation shall be: 7201 N.W.11<sup>th</sup> Place, Gainesville, Florida 32605.

# Article III

Duration. The period of duration of this Corporation shall be perpetual.

### Article IV

<u>Purpose</u>.
