ARTICLES OF INCORPORATION  
OF

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE ONE

The name of the Corporation is Jim Stecher Heating & Cooling, Inc. The mailing address of the Corporation is 4510 S. 102<sup>nd</sup> Street West, Bradenton, Florida, 34210.

ARTICLE TWO

The duration of the Corporation is perpetual.

ARTICLE THREE

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.

B. To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

ARTICLE FOUR

The aggregate number of shares which the Corporation is authorized to issue is 10,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

## ARTICLE FIVE

The street address of the initial Registered Office of the Corporation is 4510 S. 102<sup>nd</sup> Street West, Bradenton, Florida 34210, and the name of its Registered Agent at that address is James M. Stecher.

## ARTICLE SIX

The number of Directors constituting the initial Board of Directors is one (1) Director. The number of Directors may be increased or decreased from time to time, but never shall be less than one. The name and address of the initial Director of the Corporation is: James M. Stecher, 4510 S. 102<sup>nd</sup> Street West, Bradenton, Florida 34210.

## ARTICLE SEVEN

The name and address of the Incorporator is as follows: James M. Stecher, 4510 S. 102<sup>nd</sup> Street West, Bradenton, Florida 34210.

## ARTICLE EIGHT

The Corporation shall elect to be taxed as an S Corporation under the Internal Revenue Code. The Corporation shall only authorize and issue one class of stock, non-voting common. No Stockholder shall do any act (including the sale or transfer of the Stockholder's stock) which shall contravene or revoke the Corporation's election to be taxed as an S Corporation.

## ARTICLE NINE

The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation or any amendment to them, and any right conferred upon the them, and any right conferred upon Shareholders is subject to this reservation.

ARTICLE TEN

In accordance with Section 607.0203, Florida Statutes, the date when corporate existence shall commence is date of file

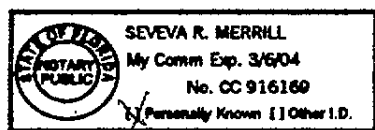
