BY THESE ARTICLES OF INCORPORATION, the incorporator forms a corporation for profit under Florida law.

1. NAME. The name of the corporation is Ben Pettinato Painting, Inc.
2. TERM. The corporation shall exist perpetually.
3. PURPOSE. The purpose of this corporation is to transact any or all lawful business for which corporations may be incorporated under Chapter 607 Florida Statutes.
4. CAPITAL STOCKS. This corporation is authorized to issue 1000 shares of common stock of a par value of \$1.00 a share.
5. REGISTERED AGENT. The initial registered agent for this corporation is Ben Pettinato and the initial registered office is located at 253 Matisse Circle East, Nokomis, FL 34275.
6. DIRECTORS. This corporation shall have two directors initially. The number of directors shall be fixed by the bylaws and may be changed from time to time.

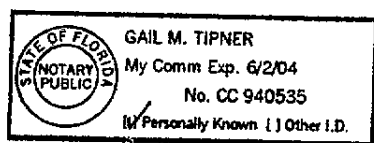


