ARTICLE I

Name and Location

1.1. The name of the corporation is **CHARLIE'S TRACTOR SERVICE**, **INC.** The mailing address of the corporation is 1000 Belcher Road South, Suite 2, Largo, Florida 33771.

ARTICLE II

Duration

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

ARTICLE III

Purpose

Capital Stock
