**ARTICLES OF INCORPORATION

**ARTICLE IV  
ELECTION OF DIRECTORS**

The manner in which the directors are elected shall be as follows: Annual election of directors shall be based upon a majority vote of the shareholders of the corporation.

**ARTICLE V  
CAPITAL STOCK**

**ARTICLE VIII  
DURATION**
