ARTICLES OF INCORPORATION

2. **Duration.** The period of its duration is perpetual, except as the same may be dissolved as provided by law.

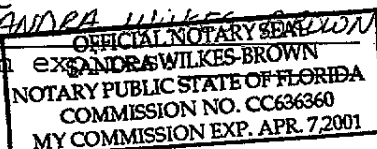
