ARTICLES OF INCORPORATION OF HEIRING HEATING & AIR, INC.



ARTICLE I-Name

The name of this corporation is Heiring Heating & Air, Inc.

ARTICLE II- Principal Office

The address of the principal office is 2765 West Charing Road, Avon Park, Florida 33825.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock
