**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of M & I MEDICAL INNOVATIONS CORP. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

ARTICLE II. COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

ARTICLE III. AUTHORIZED SHARES

The maximum number of shares that the corporation is authorized to have outstanding at any time is 1000 shares of common stock having a par value of \$1.00 per share.
