ARTICLES OF INCORPORATION OF SOUTHERN PRIDE LANDSCAPE SUPPLY COMPANY

- 1. Name. The name of the corporation is: SOUTHERN PRIDE LANDSCAPE SUPPLY COMPANY.
- 2. Purpose. The corporation may engage in any legal business:
