Pursuant to the provisions of § 607.1006, Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Intermarine.net, Inc.

The name of the Corporation is IMN Communications, Inc.

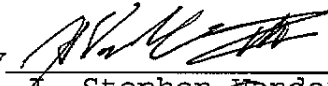
THIRD: This amendment was adopted by the Board of Directors on the 21st day of February, 2002 without shareholder action. No shareholder action was required for this amendment.

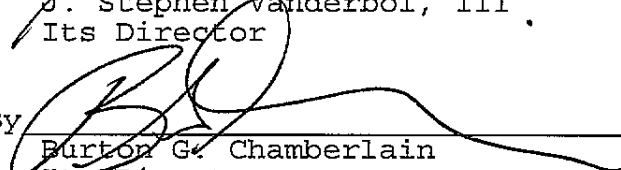
