Your representative kept stating "It was Mailed."

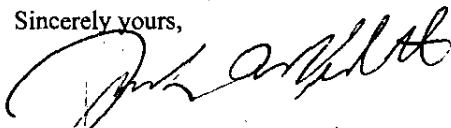
Unfortunately, all attempts have failed.
