The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is **P&P COURIER SERVICES, INCORPORATED.**

ARTICLE TWO

ARTICLE THREE

CORPORATE DURATION

This corporation shall commence existence upon the filing of these Articles of Incorporation by the Department of the State of Florida and shall have a perpetual existence.

ARTICLE FOUR

PURPOSE OR PURPOSES
