My name is Steve Schwartz and on June 12, 2000, an application to open a corporation in the name of Beach Place Realty, Inc. was filed with the State of Florida with me as the Principal. This was my first experience at starting a corporation and the process that ensued.

I contacted the Florida Division of Corporations on July 18 after discovering I did not know or remember my tax id number. This came about as a result of a conversation I had with another business owner, and their making me aware of this fact that I should have one as the Principal of the Corporation named Beach Place Realty, Inc.

A representative of the agency informed me at that time that Beach Place Realty, Inc. was now considered "inactive" and had been since September 21, 2001. It was explained to me that every year, a \$150 renewal fee accompanied by annual reports/paperwork were required and none of my funds or paperwork had ever been received.

Upon further investigation, I was also informed that on June 26<sup>th</sup>, 2000, two weeks after I initially filed my application for Beach Place Realty, an address mailing change that I never authorized was initiated. This mailing address was for P.O. Box 2460, Key West, FL 33045, an address and location that I have never received mail or lived.

It is unclear to me how this confusion could have happened, again given the fact that I never authorized this as I discussed with a representative from the FL Division of Corporations. Together we came to the conclusion that some sort of clerical error must have occurred. Unfortunately, this error coupled with the fact that I was a new business owner, any notifications that were sent to me, never made it to my mailing address of PO Box 39433, Ft. Lauderdale, FL 33339-9433 nor my Principal address of 1731 NE 28<sup>th</sup> Street, Ft. Lauderdale, FL 33334.

I would like to request that my original application with the correct mailing address be reinstated at this time. It is my understanding that a check in the amount of \$450 is due to bring Beach Place Realty, Inc. current in the state of Florida.

If there is any additional paperwork or forms that I may need to supply you with in order to complete and expedite this process, please send those to my attention as quickly as possible so that I can do the same in returning them to you.
