**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation for such corporation.

**Article I  
Name of the Corporation**

The name of the corporation is WebsideArt Inc.

**Article II  
Principal Place of Business and Mailing Address**

The initial principal place of business and mailing address of the corporation shall be at 2401 S Miami Avenue, Miami, FL 33129-1527.

**Article III  
Purpose of the Corporation**

This corporation may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

Capital Stock**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is ten million (10,000,000) shares of common stock at a \$1 par value each.

The right of indemnification herein provided shall not be exclusive of other rights to which any such person may now or hereafter be entitled to as a matter of law.

Term**

The corporation shall exist perpetually until dissolved by due process of law.


