

**ARTICLES OF INCORPORATION
OF
CATALYST PUBLISHING, INC.**

By these Articles of Incorporation, the undersigned forms a Corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name of this Corporation is:

CATALYST PUBLISHING, INC.

ARTICLE II

TERM OF EXISTENCE: This corporation shall exist perpetually and shall commence upon the filing of these Articles of Incorporation by the Department of State.

ARTICLE III

CORPORATE PURPOSES: The corporate purposes are to engage in the transaction of any lawful acts, activities or businesses for which corporations may be organized under the laws of the State of Florida or the United States.

ARTICLE IV

CAPITAL STOCK: The shares of stock of this Corporation shall consist of only one class. The maximum number of shares of stock this Corporation is authorized to have outstanding at any one time is: Five hundred (500) shares of Common Stock having One Dollar (\$1.00) par value.

ARTICLE V

INITIAL CAPITAL: The amount of capital with which this Corporation will begin business will not be less than \$500.00.

ARTICLE VI

REGISTERED OFFICE: The street address of the registered office of this Corporation is 1800 Second Street, Suite 870, Sarasota, Florida 34236. The Board of Directors may from time to time move the registered office to any other address in Florida. Principal address is the same as the above address.

ARTICLE VII

DIRECTORS: This Corporation shall have one Director initially. The number of Directors may be modified from time to time by By-Laws adopted by the Shareholders.


