

ARTICLES OF INCORPORATION
OF

ABETTA-TECH, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is **ABETTA-TECH, INC.**

ARTICLE II

The purpose for which the corporation is organized is to conduct any and all business permitted under the law.




