**ARTICLES OF INCORPORATION
OF
CARY L. STOWE, M.D., P.A.**

THE UNDERSIGNED, acting as sole incorporator of **CARY L. STOWE, M.D., P.A.** under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME**

The name of the corporation is **CARY L. STOWE, M.D., P.A.**

**ARTICLE II
PURPOSE**

The purpose of the corporation is to provide medical services.

**ARTICLE III
SHARES**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, one cent (\$.01) par value per share.

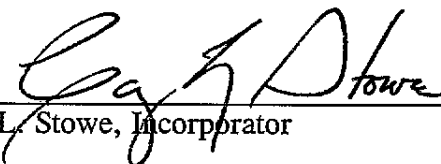
