ARTICLES OF INCORPORATION
OF
CITRUS ADVENTURES, INC.

I, the undersigned, acting as the incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for the Corporation.

1. The name of the corporation is Citrus Adventures, Inc.
2. The corporation shall have a perpetual existence.
3. The purpose for which the corporation is organized is to engage in any activities or business permitted under the laws of the United States and Florida.
4. The corporation shall have the authority to issue 10,000 shares of capital stock, all of which shall be common stock, with a par value of \$1.00 per share.

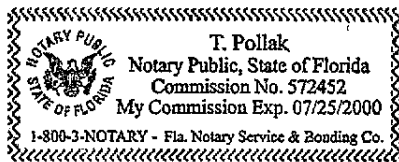

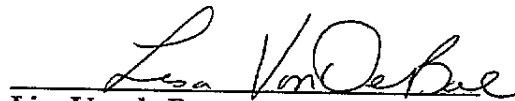
