ARTICLES OF INCORORATION

OF

DESIGN JEWELRY STUDIO, INC.

The undersigned subscriber, a natural person competent to contract, hereby associate herself together to form a corporation under the Laws of the State of Florida, Chapter 607, and subject to the following provisions:

ARTICLE I - NAME

The name of the corporation shall be:

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of filing of the Articles of Incorporation.

ARTICLE III - PURPOSE

- i. Engage in the acquisition, ownership, sale, distribution and licensing of patents, improvements and franchises, trademarks and trade names, and to operate thereunder.
- j. Enter into, make and perform contracts of every kind and description with any person, firm or association, corporation and body politic conducive to the attainment of any of the objectives or purposes of the corporation.
- k. Enter into any and all types of agreements relating to secure, in any way, the debts or obligations of any other persons, firms and or corporations.
