On February 11, 2002, we timely filed the Annual Report/Uniform Business Report (the "UBR") with the Florida Department of State (the "Department"). On April 10, 2002, the Department rejected the filing and returned same to our office on the grounds that the Federal Employer Identification Number (FEIN) was missing (see enclosed copy of the Department's letter).
