**ARTICLES OF INCORPORATION  
OF

Pursuant to the Florida Business Corporation Act, the undersigned incorporator of Corpus Business Solutions, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

**ARTICLE I  
NAME AND ADDRESS**

**ARTICLE II  
BUSINESS AND ACTIVITIES**

The Corporation's incorporator is Scott T. Farrell, 100 North Tampa Street, Suite 2700, Tampa, Florida 33602.

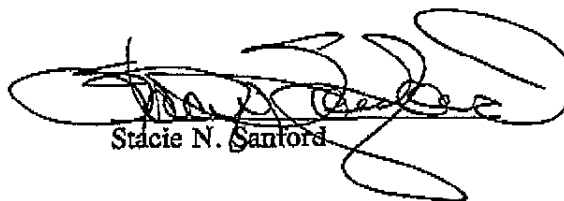
