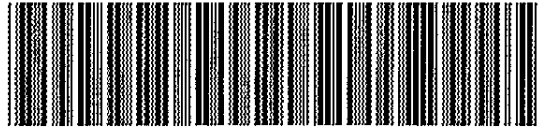

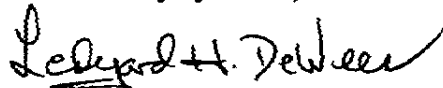

Pursuant to Florida Statute Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation and does certify as follows:

1. The name of the corporation is: RENO TV, INC.
2. The effective date of these amendments to these Articles of Incorporation is March 22, 2004.
3. The number of votes cast for the amendments by the shareholders was sufficient for approval and each voting group, constituting common stock and preferred stock, entitled to vote separately on the amendments cast sufficient votes in each voting group to constitute approval of the amendments by each voting group.
4. ARTICLE I is hereby revoked in its entirety and a new ARTICLE I is adopted as follows:

"ARTICLE I

The name of the corporation is: S E REALTY SERVICES, INC."

5. ARTICLE V is hereby revoked in its entirety and a new ARTICLE V is adopted as follows:

"ARTICLE V

The total authorized capital stock of this corporation shall consist of Fifty Million (50,000,000) shares of voting common stock, having a par value of \$0.001 each, amounting in the aggregate to Fifty Thousand Dollars (\$50,000.00). All stock when issued shall be nonassessable and fully paid for and shares of the corporation are not to be divided into classes. Each share of stock shall be entitled to one vote."
