Pursuant to Florida Statute Section 607.1006 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation and does certify as follows:

- 1. The name of the corporation is: RENO TV, INC.
- The effective date of these amendments to these Articles of Incorporation is March 22, 2004.
- 3. The number of votes cast for the amendments by the shareholders was sufficient for approval and each voting group, constituting common stock and preferred stock, entitled to vote separately on the amendments cast sufficient votes in each voting group to constitute approval of the amendments by each voting group.
