ARTICLE I - NAME

The name of this corporation is SUNNY ISLES DRY CLEANERS, INC.

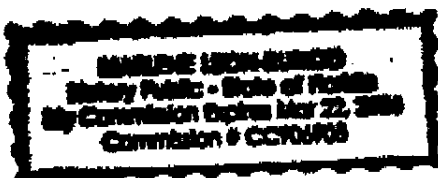


