The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby form a Corporation for Profit under the provisions of Section 607 of the Florida Statutes, with all powers, rights, privileges, and immunities; and to that end, sets forth by these Articles:

ARTICLE I - NAME

This Corporation shall indemnify any Officer or Director, or any former Officer or Director, to the full extent permitted by law.


