Articles of Incorporation

ValueServe Trading, Inc.

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I – Name: Principle Office

The name of this Corporation shall be **ValueServe Trading, Inc.** (the “Corporation”). The street address and the mailing address of the initial principal office of the Corporation shall be 867 Bay Esplanade, Clearwater, Florida, 33767, or such other place as may be designated by the Board of Directors.

Article II – Capital Stock

The Corporation shall have the authority to issue 10,000 shares of voting stock, with a par value of \$1.00 per share.

Article III – Registered Office: Registered Agent

The street address of the initial registered office of the Corporation shall be 867 Bay Esplanade, Clearwater, Florida, 33767. The initial Registered Agent of the Corporation shall be Raymond J. Fitzgerald, Jr.

Article IV – Incorporator

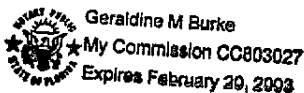
